

HI-AM Conference Author Agreement

This Agreement is entered into by and between the Holistic Innovation in Additive Manufacturing (HI-AM) Conference (hereinafter referred to as the “Conference”) and the authors of the manuscript (hereinafter referred to as the “Authors”), as represented by the individual submitting the manuscript on their behalf, whether or not that individual is an Author (hereinafter referred to as the “Submitter”).

1. Copyright, Licensing Terms, and Publication Rights

- 1.1. The Authors retain copyright ownership of the published manuscript, along with the intellectual property described within the work.
- 1.2. The Authors grant the Conference and the University of Waterloo the right of first publication with the manuscript simultaneously licensed under a [Creative Commons Attribution-Non-Commercial 4.0 International License](#) (CC BY-NC 4.0) that allows others to share the work non-commercially with an acknowledgment of the work’s authorship and initial publication in the Conference proceedings.
- 1.3. Authors can enter separate, additional contractual arrangements for the non-exclusive distribution of the Conference proceedings’ published version of the manuscript (e.g., post it to an institutional repository or publish it in a journal or book), with an acknowledgment of its initial publication in the Conference proceedings.

2. Originality and Plagiarism

- 2.1. The Authors confirm that the submission is original, has not been previously published, and does not infringe upon the intellectual property rights of any third party. The submission does not contain any form of plagiarism, and all sources have been appropriately cited.
- 2.2. The Authors confirm that for figures, data, and text adopted from other sources, with or without modifications, it is their responsibility to ensure that all necessary permissions are obtained from the publisher and/or creator. This includes verifying that the correct references are cited, and all required attributions are provided in accordance with the applicable copyright terms. The Authors understand that the Conference reserves the right to request a copy of the obtained permissions at any point during the review, publication process, or afterward.
- 2.3. The Authors give permission to the Conference to check their manuscript for plagiarism using specialized software. The Authors understand that submissions with a high level of plagiarism will be automatically rejected, and it is their responsibility to ensure that the work is original and that all sources are properly cited. Any instances of extensive copying or failure to appropriately attribute content will result in the rejection of the manuscript.

3. Authorship and Contributions

- 3.1. The Authors confirm that each individual listed as an author meets the criteria for authorship, having made substantial contributions to the research, analysis, and writing of the submission. All Authors have agreed to be included and take responsibility for their contributions.

4. Conflicts of Interest

- 4.1. The Authors agree to disclose any potential conflicts of interest related to the submission, including but not limited to financial interests, professional relationships, or personal affiliations that may be perceived to influence the submission.

5. Generative Artificial Intelligence (AI) Usage

- 5.1. The Authors agree that the use of generative AI technologies in manuscript preparation is restricted solely to language editing. The Authors agree that AI cannot be listed as an author, and applications such as data analysis, image generation or augmentation, and text authoring are not permitted.
- 5.2. If the Authors use generative AI for language editing, they acknowledge to include a statement specifying the tool used, the extent of its use, and confirming that they have thoroughly reviewed and edited the AI-generated content. By doing so, the Authors affirm authorship of the final text and accept full responsibility for it.

6. Submission and Deadlines

- 6.1. The Authors agree to submit the manuscript in accordance with the specified guidelines and deadlines. The Authors understand that failure to meet submission requirements, manuscript formatting guidelines, or deadlines may result in the submission being excluded from the Conference proceedings.

7. Presentation Obligations

- 7.1. The Authors acknowledge that at least one presenting author is required to participate in the Conference in order to present the work. The Authors confirm that if their accepted abstract is not presented at the Conference, the corresponding manuscript will be removed from the Conference proceedings, even if the manuscript was accepted prior to the presentation dates.

8. Fees

- 8.1. The Authors acknowledge that there may be fees associated with the publication of the manuscript, which must be paid in full prior to the publication date. Failure to pay these fees will result in the manuscript being excluded from the Conference proceedings. Any such fees will be clearly communicated on the Conference website.
- 8.2. The Authors, if they choose to participate in the Conference and regardless of whether they intend to present, acknowledge their responsibility for paying any applicable registration fees, as well as all travel and accommodation expenses, unless otherwise specified by the Conference Organizers. Refund policies will be communicated on the Conference website.

9. Review and Acceptance Process

- 9.1. The Authors acknowledge that the manuscript will undergo a single-blind peer-review process, and they agree to revise and resubmit the manuscript if required by the reviewers. The Authors acknowledge that the final acceptance of the original or revised submission is at the sole discretion of the Conference Editorial Board.
- 9.2. The Authors confirm that only one round of revisions is allowed, and if all requested changes are not addressed in that round, the manuscript will be rejected.

11. Ethical Guidelines

11.1. The Authors agree to comply with the highest ethical standards in the research and presentation of the submission, including adhering to ethical guidelines for human subjects or animal research (where applicable) and ensuring that all necessary permissions and approvals have been obtained.

12. Submission Withdrawal

12.1. The Authors may withdraw their submission at any time before the manuscript is accepted or the final decision is made, provided that the withdrawal request is submitted in writing to the Conference Organizers.

12.2. Any publication fees paid prior to withdrawal are non-refundable.

13. Amendments

13.1. The Conference reserves the right to amend the terms and conditions outlined in this agreement. Any amendments will be communicated to the Authors, who will be required to review and accept the updated terms prior to any further action related to the submission.

14. Termination

14.1. The Conference reserves the right to terminate this agreement and exclude the Authors' submission from the Conference proceedings if they fail to comply with any of the terms outlined above, including failure to meet deadlines, adhere to ethical guidelines, or present the submission.

14.2. If any violations of the terms become evident after the publication of the proceedings, the Conference reserves the right to remove the accepted manuscript from the published proceedings without prior permission from the Authors. This may include, but is not limited to, issues related to plagiarism, data falsification, or failure to meet the Conference's ethical standards. The decision to remove the manuscript will be at the sole discretion of the Conference Editorial Board, and the Authors will be notified of such action.
